COOK TEAM INFORMATION

1. Arrival/Set -up begins on Friday, May 27th starting at 8:00 am. and must be completed by 5:00 pm. Departure from the park begins immediately after the Awards Ceremony and must be concluded by 12:00 noon on Sunday, May 29th.
2. Space, assignment of teams and vending requests will be on a first come, first serve basis and will only be confirmed with payment of fees.
3. Entry fees must be received no later than May 13, 2011 to avoid higher entry fees. Entry fees must accompany the Registration Form, and are **NON-REFUNDABLE**.
4. There will be a Cook Team meeting on Friday, May 27th at 5:00 pm.
5. Ice will be available for purchase and will be delivered by request to Cook Teams.
6. Proper disposal of gray water is required. Collection containers will be provided on site.
7. All Cook Team spaces must be equipped with a Fire Extinguisher.
8. No Pets are allowed in Tom Varn Park, except for service animals.
9. Alcohol is allowed for personal consumption **ONLY**, and **ONLY** within the boundary of Cook Team space.
10. Cook Spaces (indicate preference):
 - () Standard Size (30 x 30') - number of spaces with access to 110 Volts may be limited
 - () Premium Size (40 x 60) - requires an additional fee of \$50.00
 - () 50 Amps (9 spaces available)
 - () 30 Amps (6 spaces available)
